(a) Highway Matters

The drain near to the church had been cleared.

Resolved - to thank ERYC for their efforts.

Bridge parapet Leconfield Road

This has now been repaired.

Speed activated sign on Bishop Burton Road

This should be in operation within the next month.

Visibility turning out of Highcroft

A resident had expressed concern about problems turning safely out of Highcroft due to the overhanging vegetation.

ERYC had been informed and were investigating.

Litter bin near bus shelter is in poor condition. ERYC have refused to replace due to the cost and Cllr Morton has investigated the costs of the Parish Council installing one. It would be £315 Ex Vat or carriage.

8pm Cllr Birmingham entered the meeting.

Resolved – Cllr Birmingham agreed to see if ERYC could get them cheaper.

Pedestrian Barrier end School Drive.

The School had previously expressed concern about the pedestrian barrier at the end of the drive. It is in the middle of the pavement, so needs to be re-sited, and is not long enough.

Resolved – Cllr Birmingham agreed to see if it could be altered.

(b) Flood prevention

Flood defences seem to be holding up following the period of heavy rain recently.

Flood Liaison Group meeting has been postponed until 28th September.

Resolved – book two places and decide who will attend at September meeting.

(c) Code of Conduct.

The Clerk outlined the new code of conduct and register of Member's Interests.

Resolved – that the Parish Council will sign up to the new Code of Conduct using the East Riding of Yorkshire Council's code as a template.

(d) Meeting with Conservative Group of Councillors
