### **Bus Services**

Wendy Vokes had responded, agreeing that it would not be viable for a bus service to travel along Bishop Burton Road from Cherry Burton. The suggested workshop would explore possibilities. ERYC are sending out letters to those who made comments on the travel survey to find out if they were happy to have their contact details made known so they could be invited to a meeting.

### **Affordable Rural Housing**

The housing survey had been delivered and Mr Siddle would be reporting back shortly.

### **New noticeboard**

Adrian Hedges had been approached for a quote but wanted some further details about what was required and whether the estimate should include new posts, removal of the existing board and posts and what materials to use.

**Resolved** – to include everything separately in the quote and then decide and to suggest a natural material such as wood.

### Application to War Memorials Trust

Mr Scully, who is applying for funding from the War Memorial Trust for the refurbishment of the Memorial has requested the PC banking details for any funds to be paid in.

**Resolved** – to supply the details.

### Internet Service in the Village

A resident had highlighted to poor internet speed in the village and enquired about community fibre partnerships.

**Resolved** – Cllr Wardale agreed to respond on behalf of the PC.

### Parish Council Committees

#### **Planning Applications received**

Conservation Area Tree work Highgate Barn – no comments.

Conservation Area Tree work Village Hall – no comments.

Tree Work 106 Canada Drive – no comments.

#### **Notice of Decision**

Erection of bin store at Costcutter, Main Street – planning permission granted with conditions.

#### **Allotments**

Cllrs Jeffrey and Stanley had inspected the allotments.

Hedge has now been trimmed back but height has not been reduced due to power lines. Northern Power has been contacted and will reduce the height.

Hedge to east also needs trimming adjacent to wooded area of Sportsfield.

**Resolved** – when the rent letters are sent out it was agreed to make the plot holders aware of their hedge trimming responsibilities.

#### **Footpath diversion off Canada Drive**

Cllr Stanley reported that ERYC had made a site visit. They looked at the proposed path and discussed how this would work with the residents. The exit from the path was also discussed. Further work would have to be done before the Schedule 14 Application was brought about.

### Sportsfield Management Committee

#### **Telecommunications Mast**

Cllr Wardale reported that the SFMC had been approached by a company called Shared Access about the possibility of putting a mast on the field which would bring a 4G service to the village. There has been a meeting and they have been informed that the land belongs to ERYC and the contract would be with them. There would be a capital inducement but this may go to ERYC.

Apparently, the proposed scheme at the Church had fallen through. An alternative location could be the allotment site, but a technical assessment would have to be done.

Cllr Baker had contacted another Parish Council that had been in negotiation with the company and had had a positive response.  
**Resolved** – to invite the company to the next PC meeting if needed.

**Hedges** have now been trimmed but needs another half day to complete the corner which would cost £150.  
**Resolved** – this was agreed.

**Access Road Fencing**  
Should be done by March.

**Third changing rooms and disabled toilet**  
Some plans have been drafted to allow disabled access. Meeting with FA representatives has been arranged as they may contribute 55% of funding. Costs will depend upon arrangement of facilities that are agreed. Other funding sources may also be investigated.

**AED**  
Formal presentation of AED from NURSE shortly and the Chairman and Cllr Baker would be attending.  
Cllr Baker would be chasing up training sessions for the equipment.

**Roof replacement**  
Quotes have been received and funding sources are being investigated.

**Owl boxes**  
York Bird of Prey centre have agreed to put a box up.

**Fish and Chip Van**  
ERYC had emailed asking for confirmation of agreement of the PC for the van to use the Sportsfield Car Park and this had been given.

Cllr Peirson had brought up concerns about the Register of Interests forms on the website, as these include member's signatures which could be a security risk.  
**Resolved** – to redact the signatures on the forms.
