Yew tree work in Conservation Area, 11 Highgate – no observations.  
**Notice of Decision**  
Erection of extension to agricultural building at Field House Farm, Etton Road – planning permission granted with conditions.

**Pavilion** – the redevelopment plans are out for tender and three builders so far have been to assess the work involved.

**Shipping Container** - Cllr Wardale confirmed that it is still on the field and has been vandalised, but has now been sealed off. Once the field dries out it will be removed by the Cricket Club.
