**Standing Orders Suspended**

Cllr Baker asked if they were elected would they attend Parish Council meetings regularly and this was confirmed. They then left the meeting.

It was agreed that a general progress update could be made in Public on the status of the County Court Claim involving the Parish Council but that details would be discussed in private and details only released after a Court decision had been made.

Outdoor Gym  
The Play Inspection Company had agreed to look at the outdoor gym equipment and add it to their next inspection.  
Tennis Club  
Zurich Insurance had responded to Cllr Baker's query about the use of the Tennis Courts by residents who are not members of the Club.  
They said that it would boil down to who is legally liable for the maintenance and upkeep of the area. There was a discussion about the ramifications of this.

(a) Highway matters  
Surface dressing is due to take place on Gardham Road, Gardham over the next few months.

The sight lines at the Highgate/Highcroft junction are being reduced by overgrown hedges again on either side.

(b) Parish Council Elections

ERYC have indicated that they have received seven nominations for the nine vacancies on the Parish Council. That would mean there probably would not be an election and there would be two vacancies for co-option.

(c) TROD on Etton Road

There was a query about whether the TROD had been rolled as the surface was still very loose.

(d) Village Green

Some of the trees next to the Village Green had been noted as overhanging on the East Riding Walkabout, as well as the poor condition of the fence.

A resident, who has a property adjacent to the area, had reported other overhanging trees to ERYC but was told that they were not their responsibility. There is a small British Gas building at the back.

**Resolved** – to check on the condition of the trees and fence that were reported by the Walkabout and find out who is responsible for the other ones.

### **Planning**

#### **Applications received**

Erection of single and two storey extension at Meadfoot, Malton Road – no observations.

Tree work at Cherry Burton Hall, Main Street – no observations.

External alterations and erection of extension to rear at 73 Canada Drive – no observations.

#### **Notice of Decision**

Erection of 6 detached dwellings with associated garages – planning permission granted with conditions.

### Sportsfield Management Committee

#### **Public Space Protection Orders**

Cllr Wardale had investigated these Orders but there was a lot of work involved. There was a discussion about using some of the areas of the land at the west side of the Sportsfield for dog walking.

**Resolved** – to discuss at SFMC meeting and consider bringing in a nature area as well as dog walking.

#### **Wood chips**

Wood chips had been donated following some trees being felled and it has been spread around the field.

#### **Kitchen**

Adrian Hedges has offered to help to refurbish the kitchen. There would still be some costs involved to refurbish the cooker, sort the hot water and electricity supply and painting the area. The estimated cost was £1500 to £2000 to be set aside from Sportfield funds.

#### **Pavilion Refurbishment**

Work is progressing well. The windows have been installed and the new panelling is nearly finished. The funding has been claimed from WREN and ERYC. The football pitch drainage work is beginning on Monday. The disabled toilet is now complete, apart from some painting.

### **Football Foundation Funding**

Cllr Baker reported that, although funding had not been awarded from the Football Foundation because of only having one football team last year, the number of teams this year may go up to five. This might mean that the funding bid could be re-submitted for the refurbishment of the changing rooms.
